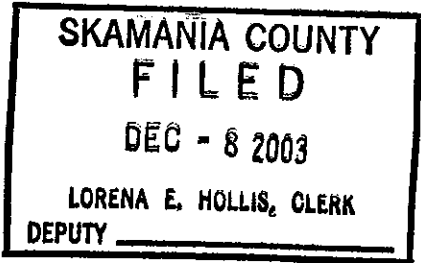

premises, NOW, THEREFORE, it is hereby


7 ORDERED, ADJUDGED, AND DECREED that the defendants, Don W Bible
