## SUBORDINATION AGREEMENT

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

- Lacamas Community Credit Union referred to herein as "subordinator," is the owner and holder of a mortgage dated March 28, 2001 which is recorded in Book 208 of Mortgages, page 66 under auditor's file No.140689, records of Clark County.
- 2. <u>washington Mutual</u> referred to herein as "lender," is the owner and holder of a mortgage dated <u>12 101</u> executed by Wilson E. Cady and Susan L. Cady (which is recorded in volume records of Skawania County) (which is to be recorded concurrently herewith).
- 3. Wilson E. Cady and Susan L. Cady referred to herein as "owner," is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4. In consideration of benefits to "subordinator" from "owner," receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his mortgage identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.
