## AMENDMENT OF WATER DISTRIBUTION LINE EASEMENT TO DESIGNATE LOCATION

THE PURPOSE of this Amendment is to forevermore designate an exact location of the water distribution line easement right of way for a pipeline or other means of carrying water from a spring located upon tax lot 01-05-03-3-0-1000-00 in T.1N, R.5E, sec. 3, Willamette Meridian, as shown on Skamania County Assessor's Tax Map dated November, 1990, Skamania County, Washington, herein known as Parcel 1 (servient parcel) to tax lot 01-05-03-3-0-0900-00 in sec. 3, T.1N., R.5E., Willamette Meridian, as shown on Skamania County Assessor's Tax Map dated November, 1990, Skamania County Washington, herein known as Parcel 2 (benefiting parcel). The easement was first created in the Agreement dated April 14, 1960 and recorded May 16, 1960 as Auditor's File No. 57007 in Book 47, Page 195, and subsequently documented in a Statutory Warranty Deed dated August 31, 1967 and recorded May 13, 1976 as Auditor's File No. 82144 in Book 70, page 946, records of Skamania County, State of Washington. An exact location of this water distribution line easement has never been specified.

WHEREAS, Daniel L. Huntington and Brian H. Wolfe, as Trustees for Cape Horn Land and Timber Trust are the owners of real property located within the Columbia River Gorge National Scenic Area described as tax lot 01-05-03-3-0-1000-00 in sec. 3, T.1N., R.5E., Willamette Meridian, as shown on Skamania County Assessor's Tax Map dated November, 1990, Skamania County, Washington, herein known as Parcel 1 (servient parcel), and also the successor in interest to George DeGroote and Ruth DeGroote, husband and wife, signatories of the original Agreement and Statutory Warranty Deed;

WHEREAS, Delos V. Schneider and Marlys C. Schneider are the owners of real property described as tax lot 01-05-03-3-0-0900-00 in sec. 3, T.1N., R.5E., Willamette Meridian, as shown on Skamania County Assessor's Tax Map dated November, 1990, Skamania County, Washington, herein known as Parcel 2 (benefiting parcel), the successor in interest to Harold Parson and Ruth Ester Parson, husband and wife, signatories of the original Agreement;

WHEREAS, the owners of Parcel 1 and the owners of Parcel 2 find the current on the ground location of the pipeline from Parcel 1 to Parcel 2 to be acceptable as is more particularly described as follows:

A strip of land, 10 feet in width, and centered on the existing water distribution line as located in the SW¼SW¼ of Section 3, Township 1 North, Range 5 East, Willamette Meridian, Tax Lot 01-05-09-3-0-1000-00, as shown on Skamania County Assessor's Tax Map dated November, 1990, Skamania County, Washington.

The centerline of said water pipeline is generally depicted on the attached Exhibit A, which by this reference is made a part hereof and is generally further described as follows:

Beginning at a point used as the spring distribution center, said point bears North 24° East, 565 feet from the Southwest corner of said Section 3, thence North 17° East, 60 feet more or less to a point on the south right-of-way line of Skamania County Road No. 11030 known as Mt. Pleasant Road, and the end of this easement.

NOW THEREFORE, Daniel L. Huntington and Brian H. Wolfe, as Trustees for Cape Horn Land and Timber Trust, Delos V. Schneider and Marlys C. Schneider, do hereby agree to amend the original easement as follows:

- 1. The current on the ground location of this above referenced pipeline from the spring on Parcel 1 to Parcel 2 described above and as depicted in the attached Exhibit A which by this reference is made a part hereof is the true and actual permanent location of the easement.
- 2. The only portion of the tract granted to Delos V. Schneider and Marlys C. Schneider in Statutory Warranty Deed dated August 31, 1967 and recorded May 13, 1976 as Auditor's File No. 82144 in Book 70, page 946, prior to subdivisions, granted use of this easement is current Tax Lot 01-05-03-3-0-0900-00 as shown on Skamania County Assessor's Tax Map dated November, 1990, also known as Lot 2 of the D. Schneider Short Plat recorded in Book 3 at page 149, under Auditor's File No. 108425 being a re-recording of a part of Short Plat recorded in Book 2, at page 124, records of Skamania County, Washington.
- 3. The width of this easement is ten feet, five feet on each side of the centerline as it now exists.
- 4. The easement grants the holder of the easement the right to enter upon said lands to construct, reconstruct, repair, operate and maintain the existing distribution line and associated existing facilities located within the right of way. It further grants the right

5. This amendment in no way grants or affirms any water rights to the above-mentioned spring. The Water Code, enacted by the Washington State Legislature in 1917, states, "all waters within the state belong to the public, subject to existing rights." Water Rights are a permitted use approved and issued only by the State of Washington, Department of Ecology.
