8. 3. 5. 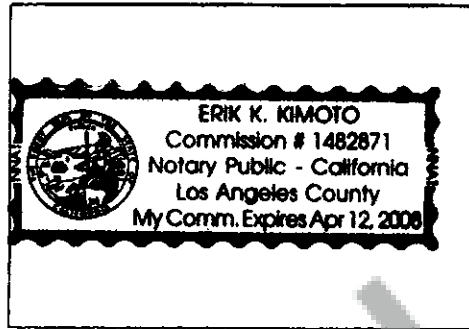

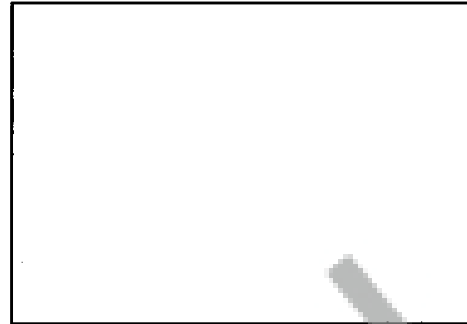
