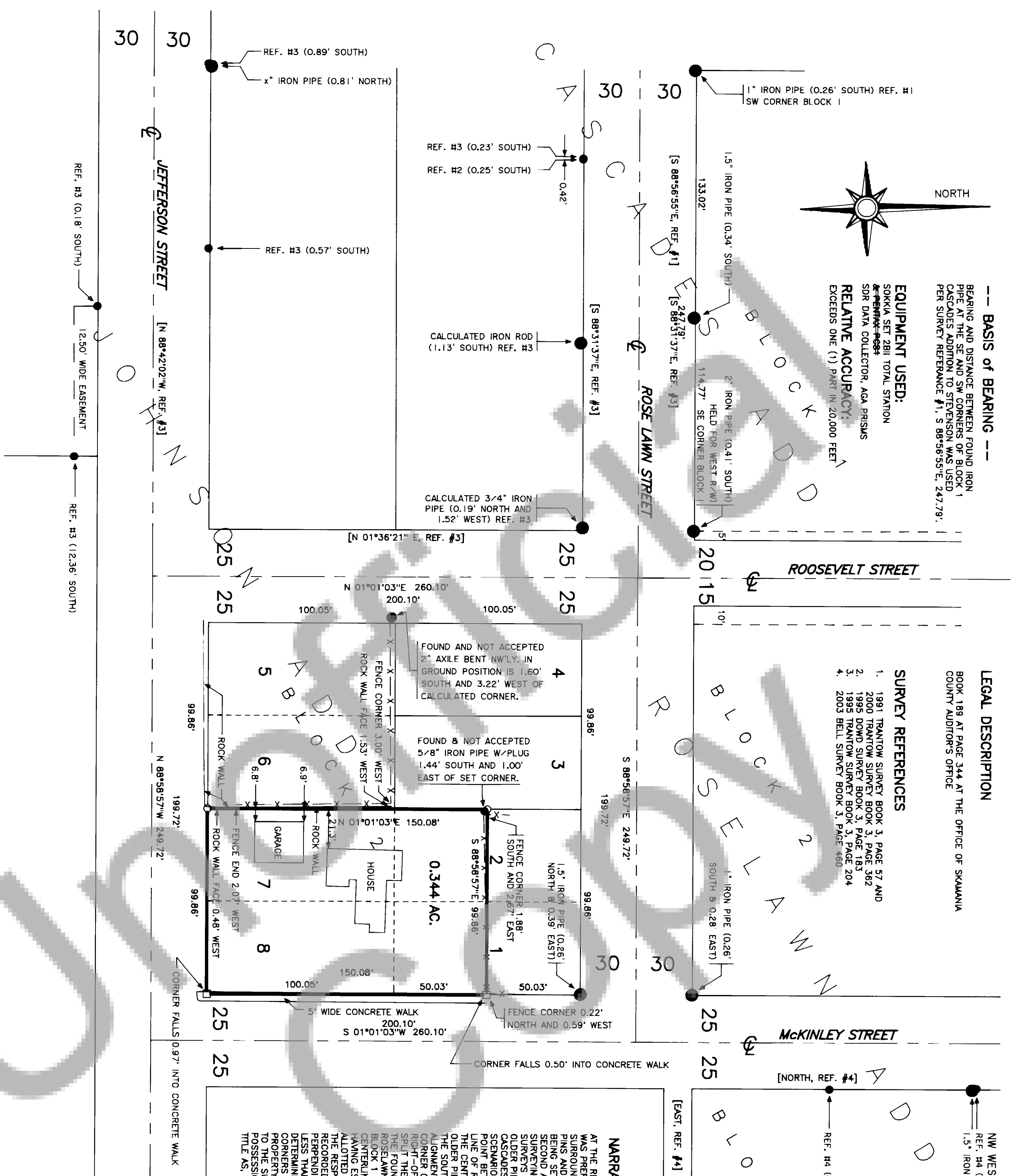
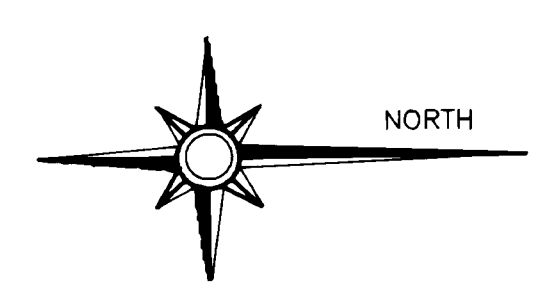

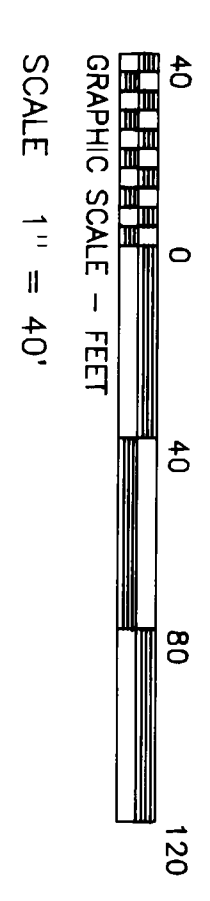
BASIS of BEARING ---

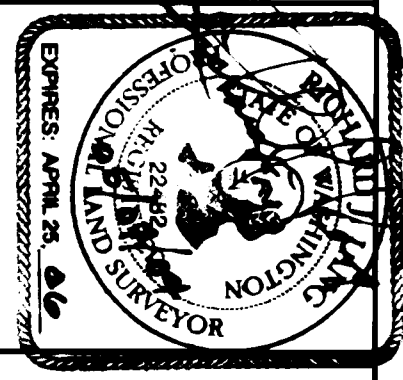

NARRATIVE
 AT THE REQUEST OF GARY DAUBENSPECK THIS SURVEY OF TAX PARCEL 03-07-36-3-4-4-5200 WAS PERFORMED UNDER THE FOLLOWING PROCEDURES WITH AN EXPANDED SEARCH OF THE SURROUNDING LOCAL BLOCKS OF BLOCK 2 OF JOHNSON ADDITION TO STEVENSON, NUMEROUS PINS AND IRON PIPES WERE FOUND. I SEGREGATED THEM INTO TWO CATEGORIES: THE FIRST BEING SET POINTS PER SURVEYS DONE SINCE THE SURVEYING RECORDING ACT AND THE SECOND AS CORNERS OF UNRECORDED SURVEYS (OLDER PIPES). SINCE THE RECORDED SURVEYS USED FOUND OLDER PIPE AS CONTROL, I DECIDED TO FIRST LOOK AT HOW THE OLDER PIPE FIT TO THE SUBDIVISIONS OF JOHNSON ADDITION, ROSELAWN ADDITION AND CASCADES ADDITION TO STEVENSON, HOLDING THE PLAT ANGLES. I CHOSE THE BEST-FIT SCENARIO AND CALCULATED THE BLOCKS ACCORDINGLY. IN MY CALCULATIONS I HELD THE MID POINT BETWEEN THE TWO FOUND OLDER PIPE NEAR THE NORTH AND SOUTH RIGHT-OF-WAY LINE OF ROSE LAWN STREET. I HELD THE BEARING BETWEEN THE FOUND OLDER PIPE MARKING THE SOUTHWEST CORNER OF BLOCK 1 OF THE CASCADES ADDITION AND THE SOUTHEAST CORNER OF BLOCK 2 OF THE ROSELAWN ADDITION AS THE EAST-WEST ALIGNMENT OF SAID MENTIONED SUBDIVISIONS. THE OLDER PIPE FOUND AT THE SOUTHEAST CORNER OF SAID BLOCK 1 OF THE CASCADES ADDITION WAS HELD FOR THE WEST RIGHT-OF-WAY LINE FOR ROOSEVELT STREET. FOR THE CENTERLINE OF MCKINLEY STREET I SPLIT THE DISTANCE ON A RIGHT ANGLE BEARING TO THE EAST-WEST ALIGNMENT BETWEEN THE FOUND OLDER PIPE MARKING THE SAID SOUTHEAST CORNER OF BLOCK 2 OF THE ROSELAWN ADDITION AND THE OLDER PIPE MARKING THE NORTHWEST CORNER OF LOT 3 OF BLOCK 1 OF THE ROSELAWN ADDITION. THE REFERENCED CASED MONUMENT MARKING THE CENTERLINE OF SCHOOL STREET ESTABLISHED THE CENTERLINE OF JOHNSON STREET. BY ALLOWED THE FULL PLATED RIGHT-OF-WAY WIDTHS OF THE SUBJECT STREETS. BY COMPARED THE RESPECTIVE RIGHTS-OF-WAY TO THE FOUND AND CALCULATED CORNERS FOR THE PERPENDICULAR OFFSET DISTANCES OF LESS THAN A FOOT DISTANCE AND IN MOST CASES LESS THAN ONE HALF OF A FOOT. THEREFORE, IN MY PROFESSIONAL OPINION I HAD DETERMINED THE BOUNDARIES AS SHOWN ON THIS PLAT TO BE THE BEST FIT FOR OLDER CORNERS RECOVERED AND RECENT SURVEYS DONE AND SURVEYED THE DAUBENSPECK PROPERTY ACCORDINGLY. OCCUPATION LINES WERE SOMEWHAT CLOSE AND SLIGHTLY SKEWED TO THE SURVEYED BOUNDARIES. THUS THERE POSSIBLE COULD BE SOME ELEMENTS OF ADVERSE POSSESSION IN PLAT. THIS SURVEY MAKES NO WARRANTY AS TO MATTERS OF UNWRITTEN TITLE AS, BUT NOT LIMITED TO, ADVERSE POSSESSION, ESTOPPEL, ACQUISITION AND ETC.
