Bk -- on Pg --), in Official Records of SKAMANIA County, WA.


The undersigned, who is the present beneficiary under said trust deed

effective immediately.



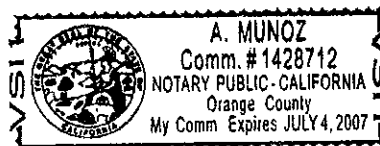
