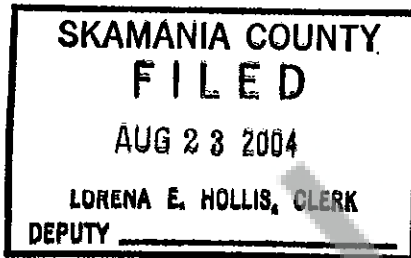

7 premises, NOW, THEREFORE, it is hereby


8 ORDERED, ADJUDGED, AND DECREED that the defendants, Basil R
