

## LOAN MODIFICATION AGREEMENT

This agreement made and entered into this 21<sup>st</sup> day of SEPTEMBER, 2004, by and between RIVERVIEW COMMUNITY BANK (hereinafter called "lender"), and Kelly G Govro, (Hereinafter called "Owner(s)")

### WITNESSETH:

WHEREAS, Lender entered into an agreement and Owner(s) owed Lender the sum of Thirty Six Thousand and 00/100 dollars (\$36,000.00) as evidenced by a note and mortgage (the term "mortgage" includes a Deed of Trust) executed and delivered on August 26, 1999, which mortgage is duly recorded on August 30, 1999, under Auditor's File No. 136152 in the public records in the jurisdiction where the mortgaged property is located which note and mortgage are hereby incorporated herein as part of this instrument:

and

WHEREAS, the undersigned owner of said premises has found it necessary and does hereby request a modification of the terms of said loan for the following reasons:

To alleviate the necessity of refinancing this loan obligation, this loan is hereby modified and extended as follows: The MATURITY DATE is hereby extended to December 1, 2004.

NOTWITHSTANDING, all other terms and conditions remain unchanged.

and

WHEREAS, the parties desire to restate the modified terms of said loan so that there shall be no misunderstanding of the matter;

THEREFORE, it is hereby agreed that, in consideration of the reasons stated above, as of the date of this agreement, the unpaid balance of said indebtedness is Thirty One Thousand Seven Hundred Sixty Three and 62/100 dollars (\$31,763.62), all of which the undersigned promises to pay with interest at \*8.750% per annum until paid and that the same shall be payable in Regular Monthly Payments of Three Hundred Eighteen and 14/100 dollars (\$318.14) to be paid monthly beginning on the 1st day of October 2004, plus a sum estimated to be sufficient to discharge taxes and insurance obligations, if applicable, (which estimated sum may be adjusted as necessary) and that in all other respects said mortgage contract shall remain in full force and effect.

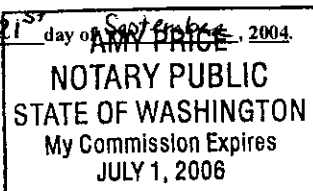

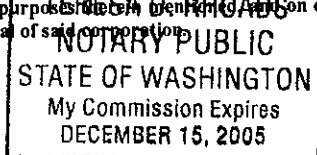
