The undersigned subordinator and owner agrees as follows:

- RIVERVIEW COMMUNITY BANK, referred to herein as "subordinator", is the owner and holder of a mortgage dated <u>APRIL 9</u>, 2003, which is recorded in Book of Mortgages, Pages under Auditor's file number <u>148265</u>, records of <u>SKAMANIA County</u>.
- 2. RIVERVIEW COMMUNITY BANK. referred to herein as "lender", is the owner and holder of a mortgage dated 10/13/2004 executed by Kody A. Price & Amy L. Price, Husband & Wife (which is recorded 10/20/04 in Volume of Mortgages, Page , under Auditor's file number 2004/248 b/7, records of Skamarchanty) (which is to be recorded concurrently herewith).
- 3. KODY A. PRICE AND AMY L. PRICE referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in paragraph 2.
- 4.
