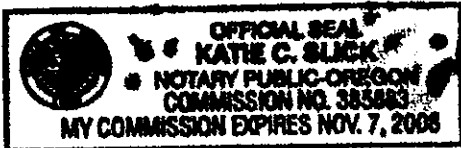

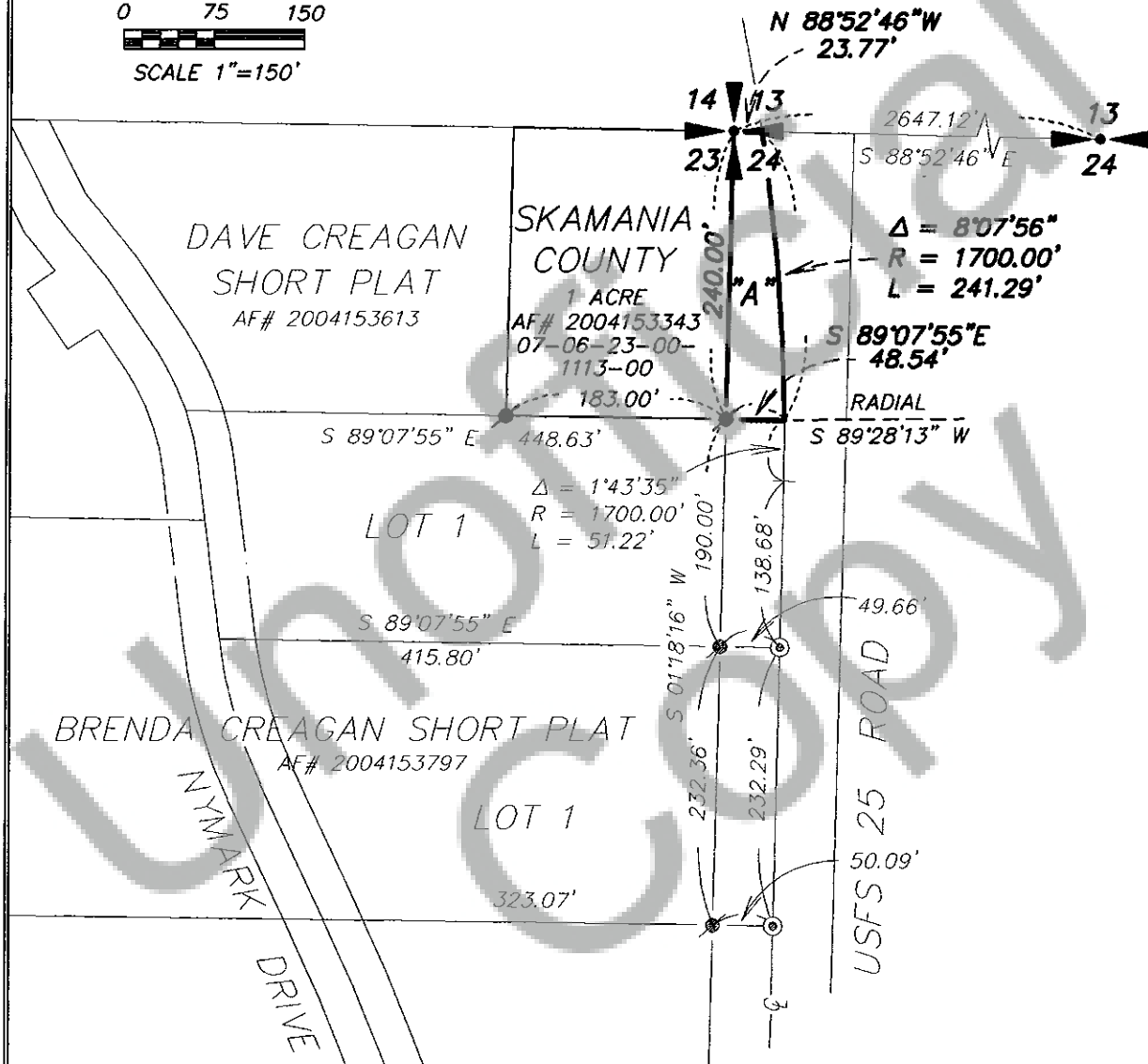
EXHIBIT "A"

PARCEL "A" (TO BE ADDED TO SKAMANIA COUNTY 1.0 ACRE TRACT):

A portion of the Northwest quarter of the Northwest quarter of Section 24, Township 7 North, Range 6 East, Willamette Meridian, Skamania County, Washington, described as follows (bearings are "NAD 83", Washington Coordinate System, South Zone):

BEGINNING at a concrete monument with BLM brass cap at the Northwest corner of Section 24; thence South $01^{\circ} 18' 16''$ West, along the West line of the Northwest quarter of Section 24, for a distance of 240.00 feet to the Southeast corner of the 1-acre tract conveyed to Skamania County under Auditor's File No. 2004153343; thence South $89^{\circ} 07' 55''$ East, on the extension of the South line of the "Skamania County tract", 48.54 feet to the centerline of the United States Forest Service "25 Road" as described in Skamania County Auditor's File No. 2004155037; thence, following said centerline Northerly, along the arc of a 1700 foot radius curve to the left (the radial bearing of which is South $89^{\circ} 28' 13''$ West) through a central angle of $08^{\circ} 07' 43''$, for an arc distance of 241.19 feet to the North line of Section 24; thence North $88^{\circ} 52' 46''$ West, 23.77 feet to the POINT OF BEGINNING.
