PARCEL "G" (TO BE ADDED TO N 1/2 N 1/2 S 1/2 NE 1/4 OF SECTION 23):

A portion of the Southwest quarter of the Northwest quarter of Section 24, Township 7 North, Range 6 East, Willamette Meridian, Skamania County, Washington, described as follows (bearings are "NAD 83", Washington Coordinate System, South Zone):

BEGINNING at a concrete monument with BLM brass cap at the Northwest corner of Section 24; thence South $01^{\circ} 18' 16''$ West, along the West line of the Northwest quarter of Section 24, for a distance of 1655.91 feet to the Southeast corner of the North half of the North half of the South half of the Northeast quarter of Section 23 and the TRUE POINT OF BEGINNING; thence South $89^{\circ} 20' 18''$ East, on the extension of the South line of said North half of the North half of the South half of the Northeast quarter, for a distance of 51.90 feet to the centerline of the United States Forest Service "25 Road" as described in Skamania County Auditor's File No. 2004155037; thence North $01^{\circ} 12' 00''$ East, along said road centerline, 331.14 feet; thence leaving said road centerline, North $89^{\circ} 17' 49''$ West, 51.29 feet to the Northeast corner of the South half of the Northeast quarter of Section 23; thence South $01^{\circ} 18' 16''$ West, 331.18 feet to the TRUE POINT OF BEGINNING.
