They took our rights as parents to make our kids mind. They did send two officers but when they came they seen her in the driveway. They Talked to her first then came knocking on our front door. I thought they were here to help so I said come on in. What a mistake, they came in and told me I was under arrest, I agreed to go with them after I had two more puffs off my cigarette. The officer grabbed my cigarette and burnt himself with my cherry. Because he did, he has the right to throw me around in my house and cuff me behind my back, when I couldn't even put my arm back there at the time. I agreed to play there game but was not a very happy camper about it. I went to jail then release to 911, ambulance took me to the hospital where I was release in Hood River Oregon, I called for a ride home.
