EASEMENT AGREEMENT

This agreement made and entered into this 9th day of December, 2004 between CAM Development, Inc, hereafter CAM, and CAM Development, Inc, hereafter CAM.

RECITAL

1. CAM is the owner of the real property known as Lot 1 of the Joseph Short Plat in Auditor File No. 2004154412 in the County of Skamania, State of Washington. See Exhibit "A" attached hereto and by this reference made a part hereof.
2. CAM is the owner of the real property known as Lot 2 of the Joseph Short Plat recorded in Auditor File NO. 2004154412 in the County of Skamania, State of Washington; . See Exhibit "A" attached hereto and by this reference made a part hereto.
3. CAM hereby grants to CAM a non exclusive easement for road purposes by virtue of a deed dated this ____ day of December 2004. Said easement is more particularly described as follows: "an easement for road purposes within a tract of land in the Northeast Quarter of Section 1, Township 2 North, Range 7 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows;

Beginning at the Northeast corner of Lot 1 of the Joseph Short Plat, recorded in Auditor File No. 2004154412; thence West 18 feet; thence Southeasterly in a straight line to a point on the East line of said Lot 1 that is 26 feet South of the Northeast corner of said Lot 1; thence North along said east line 26 feet to the Point of Beginning . See Exhibit "B" attached.

WITNESSETH:

1. The duration of said non exclusive easement shat be perpetual and said no exclusive easement shall be a burden on and run with the land.
2. CAM and CAM further agree, for themselves, their respective heirs, personal representatives, successors and assigns, that the maintenance of the non exclusive roadway easement shall be the joint responsibility of said parties granted this easement; said cost and maintenance shall be shared equally.

This agreement shall bind and insure to the benefit of, as such circumstances may require, not only the immediate parties hereto, but also their respective heirs, executors, administrators and successors in interest as well.

3. NO parking shall be permitted in the easement.




