Use only when a manufactured home (whose title has been eliminated) is being moved to land with a different legal description AND will become part of the reat property to which it will be moved and affixed. Additional fees may include: a title elimination fee and a Mobile Home Affairs Fee. Subagents will charge an additional service fee. (Fees are subject to change without notice.)
- SECTION 4 Take the properly completed Manufactured Home Application and all necessary supporting documents to the County Auditor/Licensing Agent Office for approval.
