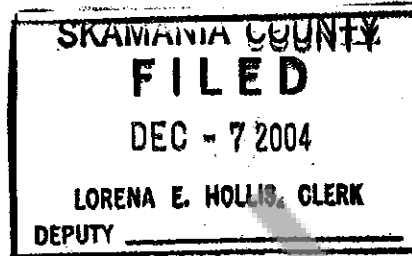

12 default. It is further


13 **ORDERED, ADJUDGED and DECREED** that plaintiff have and is hereby
