On December 30, 2002, a Second Amended Preliminary Order of Forfeiture was entered by the court, in which a typographical error for the amount of funds listed for Bank of America account number 23840-09292 for the \$28,959.30 was corrected. Based upon the plea agreement, the amended plea agreement, the pre-sentence investigation and the other files and records herein, the Court finds that defendant Gerald Bollin had interests in said properties that are forfeitable under the above cited statutes.
