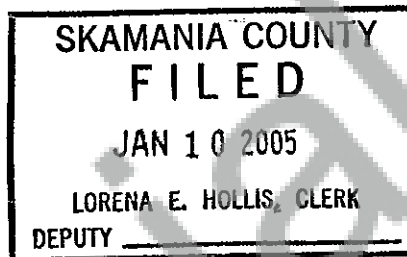

9 fully advised in the premises, NOW, THEREFORE, it is hereby


10 ORDERED, ADJUDGED, AND DECREED that the defendants, Micheal R
