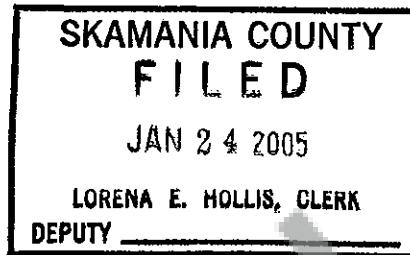

16 It is further


17 ORDERED, ADJUDGED and DECREED that plaintiff have and is hereby


