The Grantors, NATHAN STEPHEN ZIEGLER and SARAH JEAN ZIEGLER, husband and wife, for and in consideration of creating easements, grant to ROBERT TODD OGLESBY, an unmarried man, as his separate estate, his successors, heirs and assigns, the following easements:

A non-exclusive easement for ingress, egress and underground utilities over, under and across the South 20 feet of Lot 11 of Block 1 of Underwood Crest Addition, as recorded in Book "A" of Plats, Page 184, records of Skamania County, Washington, and the South 113.39 feet of the West 10 feet of said Lot 11. The utility portion of this easement is for buried utility lines only; no overhead utility lines are allowed.

It is the intent of the Grantors to create a common driveway with the Grantee along the South 113.39 feet of the West 10 feet of said Lot 11, which is the common boundary with the Grantee, who is executing an easement simultaneously. The centerline of this driveway shall be the western surveyed boundary line of said Lot 11 and shall be constructed on the property so that one-half of the paved driveway shall be on Lot 11. Grantors hereby agree with the Grantee to share any improvements to said driveway equally with the Grantee, with the exception that if the Grantors cause any extraordinary damage to the driveway they shall pay for the repair of said damage. This covenant shall be binding upon the Grantors' heirs, successors and assigns. The cost of snow removal shall be shared equally between the parties.
