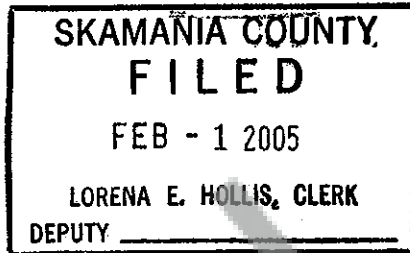

15 It is further


16 ORDERED, ADJUDGED and DECREED that plaintiff have and is hereby
