IRVIN A. SCHMIT and RUTH A. SCHMIT


WHEREAS, IRVIN A. SCHMIT and RUTH A. SCHMIT of Vancouver, Clark County, Washington, are husband and wife; and

SCHMIT, all property of every kind or nature then owned by said parties shall vest in and become the separate and individual property of the said IRVIN A. SCHMIT.


