A portion of the road lying in the Southeast Quarter of the Southeast Quarter of Section 35, township # North, Range 7 East of the Willamette Meridian, known as the Rock Creek Lane, a private road accessing the J Hafford Short Plat, having a width of sixty (60) feet with thirty (30) feet on either side of the following described centerline:

Commencing at the Southeast corner of said Section 35;

Thence North 0303'21" West along the east line of said section 35, a distance of 617.16 feet.

Thence South 86 24'49" West, a distance of 41.60 feet to the intersect of the centerline said Rock Creek Lane and the West right of way line of Inman Cemetery road and the True Point of Beginning:

Thence continuing along said centerline, along a curve concave to the north having a radius of 100.00 feet and a central angle of 33 35'10" and being suspended by a chord which bears North 76 47'36" West 57.78 feet, a distance of 58.62 feet;

Thence North 60 00'01" West, a distance of 29.35 feet to the beginning of a curve tangent to said line;

Thence along a curve concave to the south having a radius of 150 feet and a central angle of 29 59'59", a distance of 78.54 feet;

Thence North 90 00'00" West, a distance of 26.55 feet to the beginning of a curve tangent to said line;

Thence along the curve concave to the south, having a radius of 150 feet and a central angle of 24 11'54" a distance of 63.35 feet;

A point 353.08 feet short of the terminus of said centerline of Rock Creek Lane on the South 65 48'06" West tangent to said curve.
