RIGHT OF WAY EASEMENT

KNOW ALL PEOPLE BY THESE PRESENTS, that I, <u>Ramona A. A strip of land 15 feet wide beginning at an existing power pole near the center of the north property line of lot 4 of Barr's Short Plat (Tax Lot 02-05-31-02-0703) and running Southeasterly to the Westerly property line of lot 4 of Turner Short Plat (Tax Lot 02-05-31-02-0200), all in the NW1/4 of Section 31, Township 2 North, Range 5 East of the Willamette Meridian, all in Skamania County, Washington,

and to construct, repair, operate, and maintain an electric distribution line or system upon the land described above and along all highways, roads or driveways abutting or upon said lands; to cut, trim, remove, and control the trees and shrubbery by machinery or otherwise to keep them clear of said line or system on a commercially reasonable basis.

The undersigned agree that all wires and other facilities, including any main service entrance equipment installed on the above-described lands by Skamania Public Utility District or at its expense, are and shall remain the property of Skamania Public Utility District and shall be removable at its option.

The undersigned covenants that she will not erect or maintain any structure that might interfere with the operation or maintenance of the line or access thereto, that she is the owner of the above-described lands, and that she has the right to execute this Right of Way Easement without the consent of any other party. This Right of Way Easement shall be binding upon and inure to the benefits of the successors and assigns of the parties.
