# LAST WILL AND TESTAMENT

OF

RAYMOND SOWL MOORE

I, RAYMOND SOWL MOORE, being of sound mind and memory, hereby do make, publish and declare this to be my Last Will and Testament.

I

I hereby expressly revoke any and all former wills and codicils made by me.

II

I request that at my death there be no open casket, no funeral procession as such, and no expensive casket. The most inexpensive and expedient method should be utilized in handling the remains; normally, although not necessarily, I consider this to be cremation, and this cremation or burial must be done without ceremony except that if desired by loved ones a simple memorial service may be conducted at a place or places convenient to those who are most concerned. I specifically ask that there be no extensive traveling or flowers or other unnecessary expense, but rather that the money be used to the glory of God, through a donation to the Dorothy Lucille Nelson Moore Memorial Scholarship Fund established in honor of my late wife for worthy students and administered by the Moore Foundation.

Of the rest, residue and remainder of my estate of every kind and nature, including copyrights, royalties, furniture and automobile, if any, and wherever situate I give, devise and bequeath to my only next of kin, my beloved children, DENNIS RAYMOND MOORE and DOROTHY KATHLEEN MOORE KORDENBROCK to share and share alike.

IV


In the event of the simultaneous deaths of my children, all of the rest, residue and remainder of my estate of every kind and nature and wherever situate I give, devise and bequeath to the Dorothy Lucille Nelson Moore Memorial Scholarship Fund, to be administered by a committee of my grandchildren. It shall contribute to the undergraduate education of my grandchildren at the Christian college or university of their choice, preferably beginning with Weimar College but not restricted thereto. This fund can also be used for graduate study outside of Weimar or other Christian colleges, if my grandchildren's vocational or professional goals cannot be met in a Christian college. In any case, a qualification for this gift is that each

beneficiary shall work at least 20 hours weekly, preferably manual in nature, which may or may not be an integral part of their education as at Weimar currently, and if Weimar College for any reason goes out of existence, the funds shall revert to the General Conference Corporation of Seventh-day Adventists, for administration of the remainder funds.

I hereby nominate and appoint my son, DENNIS RAYMOND MOORE, as Executor of this, my Last Will and Testament, but if for any reason he is not able to act, then I nominate and appoint my daughter, DOROTHY KATHLEEN MOORE KORDENBROCK, as the Executrix hereof. Either of the above named nominees who is appointed and qualified shall be authorized to act without bond.
