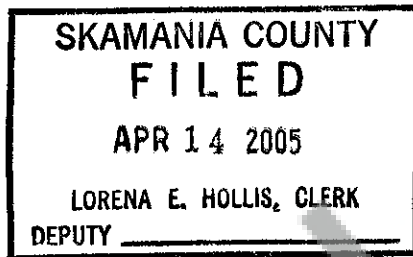

18 \$195.00, and reasonable attorneys' fees of \$750.00, for a total judgment


