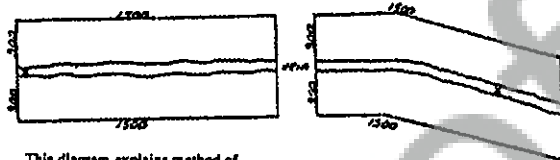

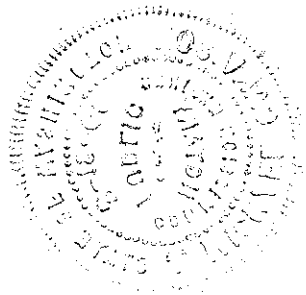
This diagram explains method of description of claim.

NOTICE IS HEREBY GIVEN That the undersigned who is are (ha declared intention to become) citizen ✓ of the United States, ha S discovered and ha S located and claimed and do hereby locate 1320 linear feet in length, and 1320 feet in width on the STEAMBOAT M.L. # 5 Lode, vein ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No 1 at the Discovery shaft (cut or tunnel), from thence 1320 feet in a WEST direction to an end post marked No 2, thence 1320 feet in a NORTH direction to a corner post marked No 3, thence 1320 feet in a EAST direction to a corner post marked No 4, thence 1320 feet in a SOUTH direction to a corner post marked No 5, thence feet in a direction to a corner post marked No 6, thence feet in a direction to said end post no 2; hereby locating and intending to claim 1320 feet in a WEST direction from the discovery to the 1320 NORTH end line, and EAST 1320 feet in the opposite direction from discovery to the 1320 SOUTH end line and feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
