to construct, reconstruct, repair, operate, and maintain underground electric facilities. The undersigned agrees that all pipes, wires, and other facilities installed on the above-described lands by Skamania PUD or at its expense, shall be and remain the property of Skamania PUD and shall be removable at its option.

The undersigned covenants that they will not erect or maintain any structure which might interfere with the operation or maintenance of the electric facilities or access thereto and that they are the owners of the above-described land, and that they have the right to execute this Right of Way Easement whithout the consent of any other party.
