WHEREAS, Longview Fibre Company, a corporation, was granted from Merle Talent and Gloria Talent, husband and wife, a permanent easement for road purposes by Statutory Warranty Deed dated August 20, 1959, filed for record with the Skamania County Auditor on August 20, 1959 under Auditor's No. 55827 in Book of Deeds No. 46 at Page No. 285 in the Records of Skamania County, Washington;

AND WHEREAS, the easement was granted over the following described parcel of land located in Skamania County, Washington:

"Beginning at the point of intersection of the South line of the tract described in Book 40, page 348 of Deeds with the West boundary of the County Road known as the Red Bluff Road in Section 2 Township 2 North Range and East of the Willamette Meridian, thence West to the East boundary of the 300 foot strip of land owned by United States of America for Power Transmission line; thence Southwesterly along the said easterly boundary of the strip of land owned by United States of America to a point 210 feet South of the North line of Section 2; thence East to a point on the West boundary of the County Road known as the Red Bluff Road to the point of beginning, all in Section Two, Township Two North Range Seven East of the Willamette Meridian and being subject to easement recorded in Book 35 at page 33.";

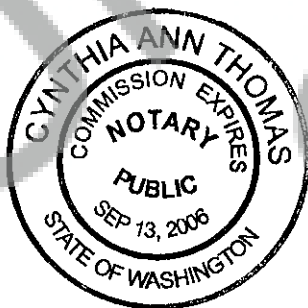
