EASEMENT

THIS EASEMENT, made this 3rd day of August, 2005, by and between Frederick Jay Holtmann, hereinafter referred to as Grantor, and Skamania County Public Utility District, hereinafter referred to as Grantee.

1. <u>Easement Grant</u>. Grantor hereby grants and conveys to Grantee a permanent easement on, over, across and along the real property described below (the "real property"). Grantee shall have the right to reasonable access to Grantor's property for the purposes set forth in paragraph 2, below. Grantee shall give Grantor reasonable notice before accessing the property. Access shall be over existing roadways, unless alternate access is agreed to by Grantor. Said property is described as:

The North 15' of the Northeast quarter of the Northeast quarter, in Section 16, Township 3 North, Range 10 East of the Willamette Meridian, Skamania County, State of Washington.

Grantor also hereby grants an additional 15' temporary construction easement in addition to the 15' permanent easement, along and across the South 15' of the North 30' of the above described property.

- 2. <u>Grantee's Use</u>. Grantee intends to use the Easement to install and maintain a water distribution and transmission system.
- 3. <u>Grantor's Use Unaffected</u>. Except for such restrictions as are reasonably necessary to protect the rights of Grantee created by this easement, Grantor shall not be restricted in the use of its property by reason of this Easement.

- 4. Termination. The rights hereby conveyed shall automatically expire if the Easement is not used by Grantee for a period of two (2) consecutive years or if Grantee, its customers, or others using the water distribution and transmission system violate any term, covenant or condition of this Agreement.
- 5. Notice. Any notice required by this Agreement, should be met if such notice is mailed, postage prepaid, to the other party at the following addresses:

- 6. Attorneys Fees. In the event that any party retains an attorney to enforce any provision of this Agreement, then the successful party shall be entitled to the award of reasonable attorneys' fees from any party in default, including fees incurred in arbitration and mediation, or incurred in state and federal trial, bankruptcy, and appellate courts and fees incurred without suit, and all court and accounting costs incurred in resolution of such dispute.
- 7. Additional Encumbrances. This Easement is granted subject to all prior easements and encumbrances of record.
