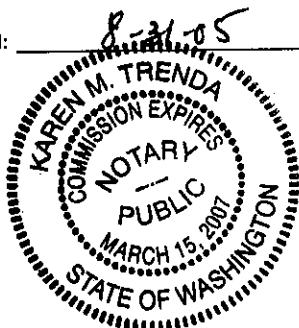

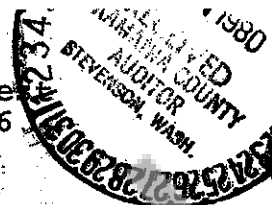

A portion of the Southeast quarter of the Northwest quarter of Section 30, Township 3 North, Range 6 East of the Willamette Meridian described as follows:
