AMENDMENT TO THE UPPER PINE CREEK COVENANTS CONDITIONS and RESTRICTIONS

WHEREAS, the Upper Pine Creek Covenants Conditions and Restrictions (hereinafter the CC&Rs) were recorded on May 13, 2004 at Doc # 2004152956 of the official records of Skamania County, Washington; and

WHEREAS, the owners of the property described on Exhibit A desire to remove their property from the CC&Rs so their property can be annexed into the Three Rivers Recreational Area, and the Owners of the property described on Exhibit B hereto desire to remain in the Upper Pine Creek development subject to the CC&Rs; and

WHEREAS, pursuant to the terms of the CC&Rs, the CC&Rs may be amended if such amendment is approved in writing by owners representing 75 percent of the lots; and

WHEREAS, the undersigned owners by their unanimous signatures represent in excess of 75 percent of the lots and by their signatures they indicate their approval of the amendments to the CC&Rs contained herein; and

NOW, THEREFORE, the CC&Rs are hereby repealed in their entirety as to the property described on Exhibit A hereto, and the CC&Rs shall remain in full force and effect as to the property described in Exhibit B hereto. Notwithstanding the above, nothing in this Amendment to the Upper Pine Creek Covenants Conditions and Restrictions shall effect any easements pertaining to the property described on Exhibits A and B or any adjoining property, and all such easements shall remain in full force and effect. Further, the CC&Rs applicable to the property described on Exhibit B may not be amended for a period of three years after the recording date of this amendment without the approval the owners representing 75 percent of the lots described on both Exhibits A and B. After the expiration of such three year period, the CC&Rs applicable to the property described on Exhibit B may be amended with the approval of the owners representing 75 percent of the lots described on Exhibit B, as stated in the CC&Rs.
