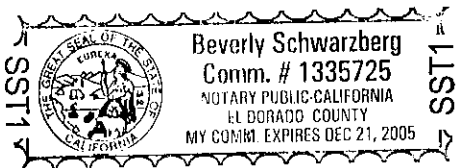

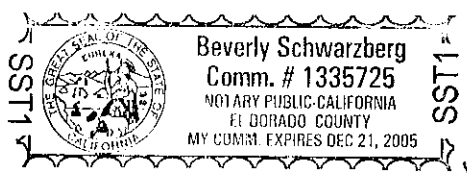

Beginning at a point in the North line of said Section 26 lying N 87°23'27" W, 328.12 feet from the West 1/16<sup>th</sup> corner of Sections 23/26 thereof; thence continuing on said line N 87°23'27" W, 351.48 feet; thence S 0°35'26" W, 900.07 feet to the centerline of Hemlock (Co.) Road (from which an iron rod bears N 0°35'26" E, 30.75 feet); thence Northeasterly along said centerline to a point, the chord of which bears N 74°11'27" E, 431.20 (from which an iron rod bears N 4°03'59" W, 36.50 feet); thence N 4°03'59" W, 768.48 feet to the point of beginning;

SUBJECT TO rights of the Public over said roads.
