COMMUNITY PROPERTY AGREEMENT

THIS AGREEMENT, made and entered into by and between EDITH G. IVERS and THOMAS R. IVERS JR. Wife and Husband, of Skamania County, State of Washington.

WITNESSETH

WHEREAS, the parties hereto have been Wife and Husband since December 29, 1985 and by the mutual helpfulness of each to the other, it is hereby agreed, in consideration of the love and affection that each bears for the other, and the mutual benefits to be derived herefrom, that each and every item and parcel of property, real personal and mixed, now owned or hereafter acquired by the parties hereto or either of them, including what might otherwise be termed separate property, is hereby declared to be the community property of the parties hereto, it being the intent and purpose of each of the parties as to any property that might be deemed separate property to be making a voluntary conveyance from one to the other and unitedly to be community so that all property shall from this date be community property of the parties.

RECORDER'S NOTE:

IT IS FURTHER AGREED that for such consideration so stated, upon the death of the said **EDITH G. IVERS** the full ownership of all of such property and property interests then shall pass to and vest in the said **THOMAS R. IVERS JR.**; or, in the like manner upon the death of **THOMAS R. IVERS JR.**, the full ownership of all such property and property interests then owned by the parties hereto, or either of them shall at once pass to and vest in the said **EDITH G. IVERS**, such vesting in either event shall be subject only to the rights of creditors by law.




