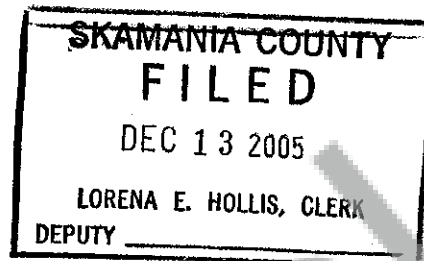

6 advised in the premises, NOW, THEREFORE, it is hereby


7 ORDERED, ADJUDGED, AND DECREED that the defendant, Rocky
