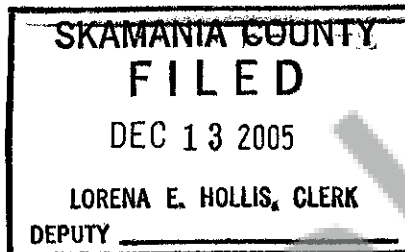


7 ORDERED, ADJUDGED, AND DECREED that the defendant, Robert J
