The Planning Department issued an Administrative Decision on October 19, 2005 for the above referenced application. On November 14, 2005 we received a letter from you requesting an amendment to alter the site plan and elevation drawings in order to indicate the corrected location of all utilities, change the location of the shop by 7 feet, change the footprint of the shop from 20' x 40' x18' to 24' x 36'x 18' and alter the footprint of the house from the approved size of 46' x 66' x18' to the new proposed size of 36' x 54' x18' with a 22' x 20' x18' attached garage, and to alter the driveway location as shown on the revised site plan. This amendment will require the attached site plan and elevation drawings to be known as your final site plan and elevation drawings.

Pursuant to SCC §22.06.080(B), a change or alteration to an approved action, if determined to be minor by the Director, may be "deemed consistent with the provisions of this Title and the findings and conclusions on the original application." The proposed request constitutes a minor change; therefore, the original decision shall be amended as stated above.

The site plan (see attached page 4) elevation drawings (see attached page 5/6) and landscaping plan (see attached page 7) to this Letter Amendment shall replace those attached to your original Administrative Decision of October 19, 2005, and shall be known as the final site plans and elevation drawings. The amendment is hereby approved.
