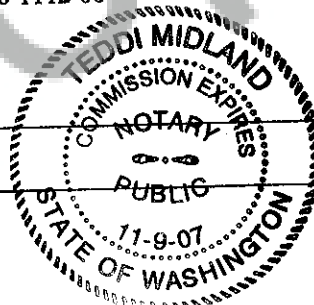

Boundary Adjustment to Lot 2 of the Pelky Short Plat

A parcel of land situated within the S½ SW¼ of Section 32, Township 2 North, Range 5 East, W.M., in the County of Skamania, State of Washington, being a portion of Lots 1 & 2 of the Pelky Short Plat as shown on the map thereof recorded December 9, 2005 in AF#2005159821, records of said County and described as follows:

Lot 2 of said short plat, PLUS a triangular parcel described as commencing at the most Southerly corner of said Lot 1 (being the most Easterly corner of said Lot 2), thence N 62°03'15" W along the Southwesterly line thereof, 195 feet to the point of beginning; thence continuing on said line N 62°03'15" W, 292.47 feet to the center of the Washougal River; thence along said River, the chord of which bears N 58°43'26" E, 84.51 feet; thence S 45°48'41" E, 259.58 feet to the point of beginning.
