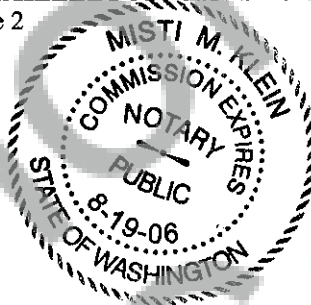
PARTIAL RECONVEYANCE
