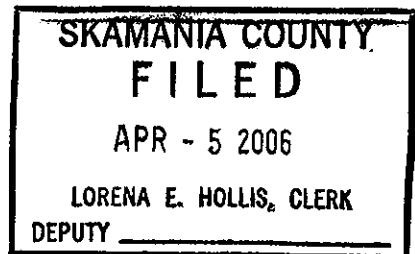

2 against plaintiff's complaint, NOW, THEREFORE, it is hereby


3 ORDERED, ADJUDGED AND DECREED that the defendants are hereby in default.
