## COMMUNITY PROPERTY AGREEMENT

This agreement, made and entered into this 2 rth day of \_\_\_, 1993, by and between Donald C. Yarnell and Esther M. Yarnell, husband and wife, of Underwood, Washington, pursuant to the provisions of Section 26.16.120 of the Revised Code of Washington, permitting agreements between husband and wife fixing the status and disposition of community property to take effect upon the death of either, Witnesseth:
