SUBORDINATION AGREEMENT

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

- Lacamas Community Credit Union referred to herein as "subordinator," is the owner and holder of a mortgage dated May 15, 2006, under auditor's file No. 2006161583, records of Skamania County.
- 2. TAYLOR BEAN: Whitaker Horse teferred to herein as "lender," is the owner and holder of a mortgage dated 5-8-06 executed by Rick W. PFEIER and Flaine T. PFEIER

 (which is recorded in volume of Mortgages, page under auditor's file No. 7006, records of SKAMANIA County) (which is to be recorded concurrently herewith).
- 3. Rick W. Pfeifer and Elaine T. Pfeifer referred to herein as "owner," is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4. In consideration of benefits to "subordinator" from "owner," receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his mortgage identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.
