The undersigned subordinator and owner agrees as follows:

- 1. Lacamas Community Credit Union referred to herein as "subordinator," is the owner and holder of a mortgage dated March 29, 2001 which is recorded in volume 208 of Mortgages, page 66 under auditor's file No. 140689, records of 答案表表 Skamania County
- 2. Lacamas Community Credit referred to herein as "lender," is the owner and holder of a mortgage dated 06/06/06 executed by WILON E COUNTY of Mortgages, page N/A under auditor's file No. 2006/16/19, records of Stamania County) (which is to be recorded concurrently herewith).
- 3. Wilson Cady and Susan Cady referred to herein as "owner," is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4.
