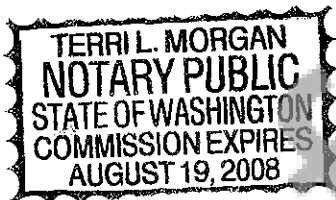

EXHIBIT 'A'

PARCEL I

A tract of land in the North Half of the Southeast Quarter of Section 20, Township 2 North, Range 5 East of the Willamette Meridian, in the County of Skamania and State of Washington, described as follow:

Beginning at a point in the center of a 40 foot County Road known as Burns Road, which is 1718.70 feet North and 1122.65 feet West of the Section Corner of 20, 21, 28 and 29, Township 2 North, Range 5 East of the Willamette Meridian; thence South 29°36' West 25.10 feet along the center of said road to Co. Eng. Station 49; thence South 44°20' West 124.35 feet along the center of said Road; thence North 93°50' West 368.16 feet, more or less, to the center of the North Fork of the Washougal River; thence North 20° East 106.4 feet; thence South 89°50' East 485 feet, more or less to the point of beginning.

EXCEPT COUNTY ROADS.

PARCEL II

A tract of land located in the North Half of the Southeast Quarter of Section 20, Township 2 North, Range 5 East of the Willamette Meridian, in the County of Skamania and State of Washington, described as follows:

BEGINNING at a point in the center of a 40 foot County Road known as Burns Road which is 1,718.70 feet North and 1,122.65 feet West of the Section corner of 20, 21, 28 and 29, Township 2 North, Range 5 East of the Willamette Meridian; thence South 29°36' West 25.10 feet along the center of said road to Co. Eng. Station 48; thence South 44°20' West 124.35 feet to the True Point of Beginning. Continuing along said road for 124 feet; thence North 89°30' West 350 feet more or less to the center of the North Fork of the Washougal River; thence upstream North 8° East 101 feet; thence continuing in a Easterly direction to the True Point of Beginning.
