

EXHIBIT 'A'

A portion of the South Half of the Southwest Quarter of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, Skamania County, Washington, described as follows:

Beginning at a $\frac{5}{8}$ " iron rod at the Northeast corner of the Southwest Quarter of the Southwest Quarter of Section 34, thence North $89^{\circ}29'28''$ West, 622.81 feet; thence South $02^{\circ}10'00''$ East, 684.44 feet to the centerline of a 60 foot road easement; thence following said centerline North $85^{\circ}40'00''$ East, 380.86 feet; thence along the arc of a 200 foot radius curve to the left for an arc distance of 114.03 feet; thence North $53^{\circ}00'00''$ East, 95.70 feet; thence along the arc of a 500 foot radius curve to the right for an arc distance of 84.36 feet; thence leaving said centerline North $12^{\circ}30'00''$ East, 518.46 feet to the North line of the South Half of the Southwest Quarter; thence North $89^{\circ}29'28''$ West, 148.08 feet to the point of beginning.

Also known as lot 15 of survey recorded in Book 1 of Surveys, Page 150, Records of Skamania County, Washington.
