



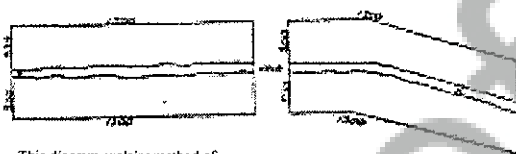

This diagram explains method of description of claims.

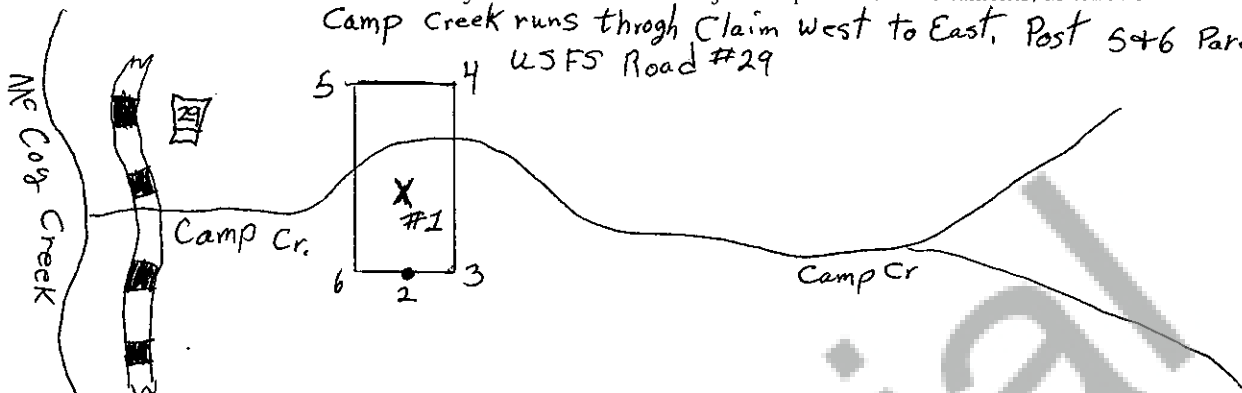

Lead Claim "Primary Gold No 1"

NOTICE IS HEREBY GIVEN That the undersigned who ~~is~~are (have declared my intention to become) citizen \_\_\_\_\_ of the United States, have discovered and have located and claimed and do ~~so~~ hereby locate ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No 1 at the Discovery shaft (cut or tunnel), from thence 1506 feet in a South direction to an end post marked No 2, thence 300 feet in a East direction to a corner post marked No 3, thence 1500 feet in a North direction to a corner post marked No 4, thence 600 feet in a West direction to a corner post marked No 5, thence 1500 feet in a South direction to a corner post marked No 6, thence 300 feet in a East direction to said end post no 2; hereby locating and intending to claim 1000 feet in a South direction from the discovery to the #2 post end line, and 500 feet in the opposite direction from discovery to the North end line and 300 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
