



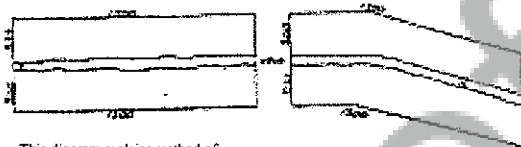

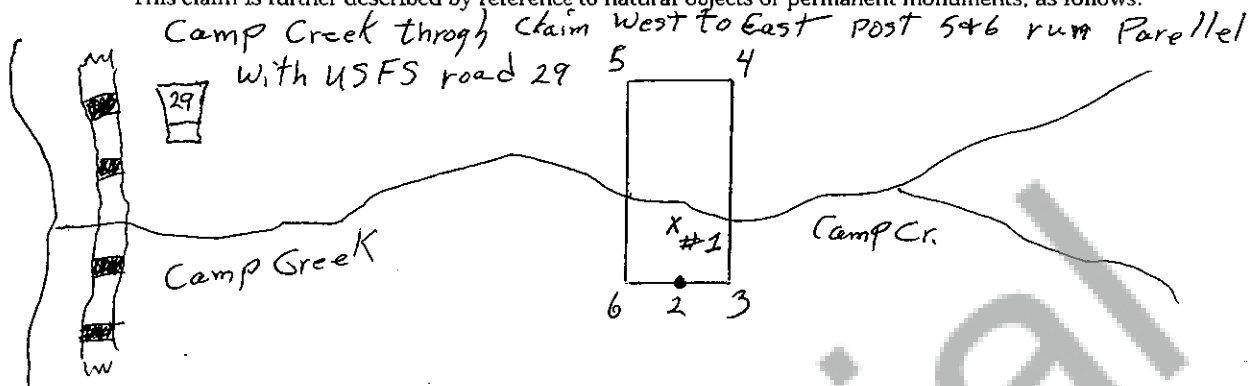


This diagram explains method of description of claim.

NOTICE IS HEREBY GIVEN That the undersigned who is/~~are~~ (has/~~have~~ declared my intention to become) citizen        of the United States, have discovered and have located and claimed and do SO hereby locate 1500 linear feet in length, and 600 feet in width on the Camp Creek T10N R8E Sec 10 Primary Gold #3 Lode, vein ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No 1 at the Discovery shaft (cut or tunnel), from thence 750 feet in a South direction to an end post marked No 2, thence 300 feet in a East direction to a corner post marked No 3, thence 1500 feet in a North direction to a corner post marked No 4, thence 600 feet in a West direction to a corner post marked No 5, thence 1500 feet in a South direction to a corner post marked No 6, thence 300 feet in a East direction to said end post no 2; hereby locating and intending to claim 750 feet in a South direction from the discovery to the #2 end line, and 750 feet in the opposite direction from discovery to the North end line and 300 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
