LAST WILL AND TESTAMENT

OF

FLORENCE KLEVELAND

I, Florence Kleveland, residing in North Bonneville, Skamania County, Washington, declare this to be my last will and revoke all former wills and codicils by me made.

ARTICLE I
Identification of Family

I hereby declare that I am a widow woman and my immediate family now consists of my daughter, KAREN PINNICK, and my son, LARRY ADAMS. I intend to make no provisions in this will for any of my children, or for the descendants of any such child that does not survive me.

ARTICLE II
Payments of Debts

I hereby direct and order that all just debts for which proper claims are filed against my estate, and the expenses of my last illness and funeral be paid by my executrix, hereinafter named, as soon after my demise as is practicable.

ARTICLE III
Specific Devises and Requests

All of the residue and remainder of my property, of whatsoever kind and nature, wheresoever situated and owned by me at the time of my demise, I give, devises and bequeath to my daughter, KAREN PINNICK, and my son, LARRY ADAMS, in equal shares, per stirpes.

ARTICLE IV
Appointment of Executrix

I nominate and appoint my daughter, KAREN PINNICK, as executrix of this my last will, to act as such without bond and without the intervention of any court, except as may be required under the laws of the State of Washington in the case of nonintervention wills. My executrix shall have, as is necessary for the administration of my estate, full power to sell, convey and encumber, without notice or confirmation, any assets of my estate, real or personal, at such prices and terms as to her may seem just; to advance funds and borrow money, secured or unsecured, from any sources; to mortgage or pledge estate property; to select any part of the estate in satisfaction of any partition or distribution hereunder, in kind, in money or both.

ARTICLE V
Taxes

I direct that all estate, inheritance and succession taxes assessed by reason of my death, whether attributable to property passing under this will or outside of it, shall be paid out of the residue of my estate disposed of by this Will without apportionment, deduction or reimbursement therefore, and without adjustment thereof among the residuary beneficiaries.

ARTICLE VI
Competency

I, FLORENCE KLEVELAND, am of legal age, competent and of sound mind and am fully able to dispose of my estate and am acting of my own free will without duress.
