7 \$8,650.05 in costs, plus post-judgment interest at 7.190% per annum on the \$599,450.57 sum;


8 2. \$343,591.05 total judgment against Ted Angelo Brothers, and Lewis Angelo,  
9 Miki Angelo, Joseph Angelo, jointly and severally, which sum includes \$8,650.05 in costs, plus  
10 post-judgment interest at 7.190% per annum on the \$343,591.05 sum. This judgment is joint  
11 and several with Sam Angelo and Sam Angelo Construction, but is not in addition to the  
12 \$599,450.57 judgment against Sam Angelo and Sam Angelo Construction;

13 3. \$34,400.05 judgment against Theodore Angelo which sum includes \$8,650.05 in  
14 costs, plus post-judgment interest at 7.190% per annum on the \$34,400.05 sum. This judgment
