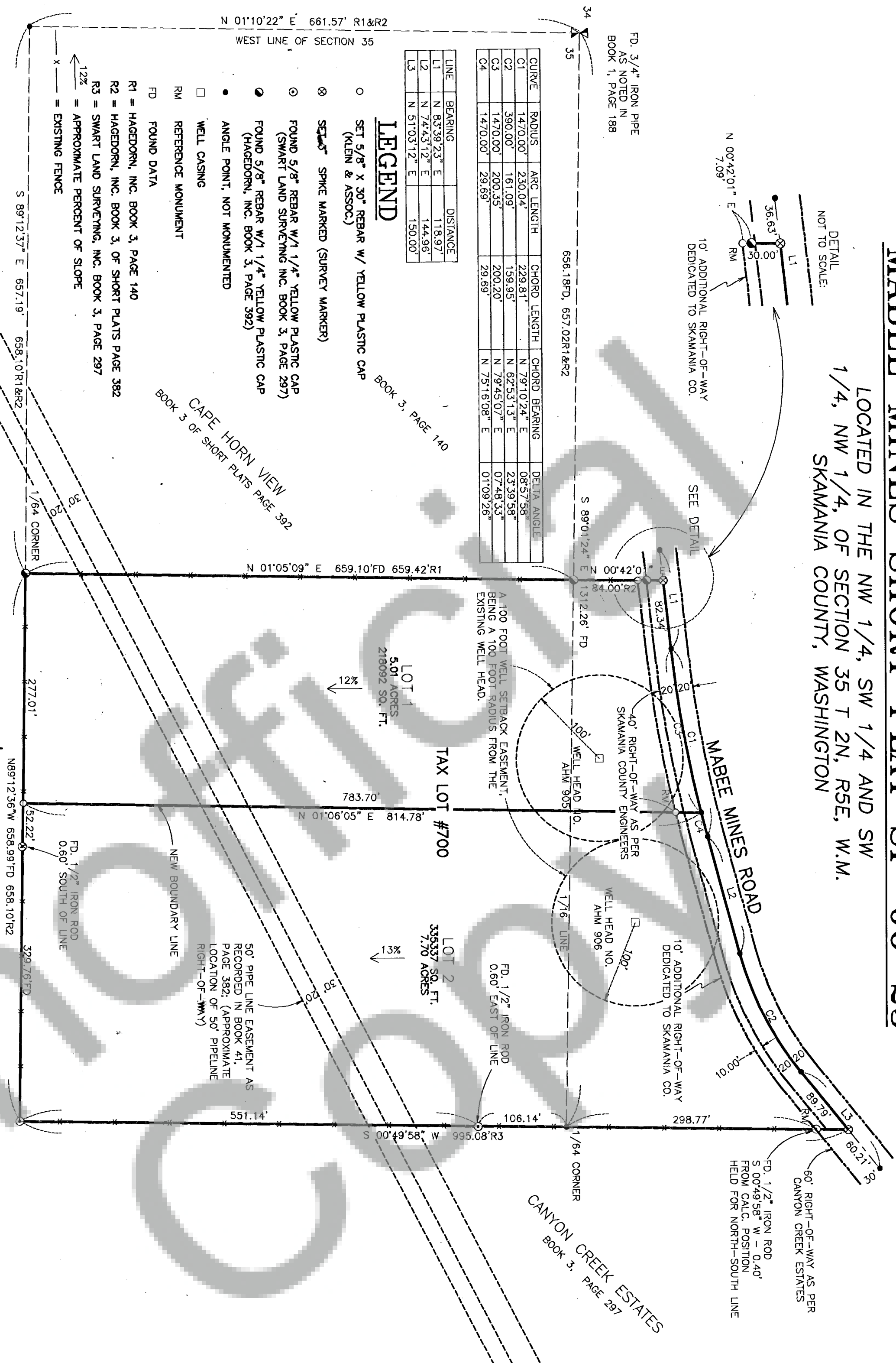


MABEE MINES SHORT PLAT SP-06-23

LOCATED IN THE NW 1/4, SW 1/4 AND SW 1/4, NW 1/4, OF SECTION 35 T 2N, R5E, W.M. SKAMANIA COUNTY, WASHINGTON



NOTES

- 1.) THIS SHORT PLAT IS LOCATED IN AN AREA MANAGED FOR TIMBER PRODUCTION AND/OR AGRICULTURAL PURPOSES. MANAGEMENT OF THOSE RESOURCES MAY INCLUDE, BUT NOT BE LIMITED TO ACTIVITIES SUCH AS SITE PREPARATION, TREE PLANTING, USE OF HERBICIDES/PESTICIDES, THINNING AND CLEAR-CUTTING OF TIMBER, SLASH BURNING, HEAVY EQUIPMENT OPERATION AND OTHER ASSOCIATED ACTIVITIES THAT ALSO OCCUR. THE PURCHASE OF PROPERTY WITHIN THIS SHORT PLAT IS HEREBY NOTICE THAT THESE USES AND ASSOCIATED ACTIVITIES WILL OCCUR ON ADJACENT AND NEARBY PROPERTIES. SUCH USES SHALL NOT BE CONSIDERED A PUBLIC NUISANCE IF CONDUCTED CONSISTENT WITH STANDARD AND ACCUSTOMED FARM AND FOREST PRACTICES.
- 2.) LANDS WITHIN THIS SUBDIVISION SHALL NOT BE FURTHER SUBDIVIDED FOR A PERIOD OF 5 YEARS UNLESS A FINAL PLAT IS FILED PURSUANT TO SKAMANIA COUNTY CODE, TITLE 17, CHAPTER 17.04 THROUGH 17.80 INCLUSIVE.

NARRATIVE OF SURVEY

THIS SURVEY WAS PERFORMED AT THE REQUEST OF JASON THOMPSON IN ORDER TO SEGREGATE TAX LOT 700 INTO TWO PARCELS AS SHOWN HEREIN. THE WEST, SOUTH, AND EAST LINES OF THE LOT HAD PREVIOUSLY BEEN MONUMENTED BY TWO PRIVATE SURVEYORS. MONUMENTS RECOVERED ALONG THE WEST LINE OF TAX LOT 700 WERE HELD AS PER A SURVEY PERFORMED BY HAGEDORN, INC. AS RECORDED IN BOOK 3, PAGE 392. EXISTING MONUMENTS ALSO RECOVERED ALONG THE EAST LINE OF TAX LOT 700 WERE HELD AS PER A SURVEY PERFORMED BY SMART LAND SURVEYING, INC. AS RECORDED IN BOOK 3, PAGE 297. MABEE MINES ROAD IS THE NORTHERLY BOUNDARY OF THE LOT AND HAS BEEN MONUMENTED BY THE SKAMANIA COUNTY ENGINEERING DEPT. THESE CENTRELINE MONUMENTS WERE FOUND AND HELD. TWO MONUMENTS WERE SET DURING THIS SURVEY ON THE SOUTHERLY RIGHT-OF-WAY LINE OF MABEE MINES RD.

PROCEDURES

A FIELD TRAVERSE WAS PERFORMED USING A TOPCON 800A.5 TOTAL STATION AND A RANGER DATA COLLECTOR. A CLOSED LOOP TRAVERSE WAS RUN AND A COMPASS RULE ADJUSTMENT APPLIED. MEETS MINIMUM STANDARDS AS DESIGNATED IN WAC 352-150-090.

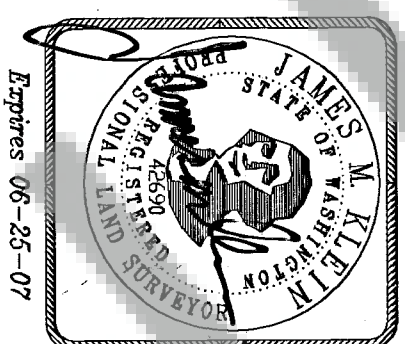
