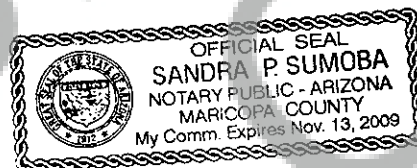

## LEGAL DESCRIPTION
